2. DETERMINE PATIENT'S INTEREST

Say: "Hennepin is participating in a national study on an online treatment program for survivors of sexual assault who use cannabis. Some of our patients have found it to be helpful and we hope it will improve treatment for survivors in the future. I can connect you with their research team to tell you more. The call would at most be 45 minutes, and you would be paid \$20-\$40 for it. Would you be willing to meet with a research assistant virtually to see if you qualify?"

- ☐ **Patient declined to speak with RA at all:** "No problem. If you do change your mind or just become curious, here is a flyer and their contact information so you can contact them. Please let them know you were referred by NVIFN." (write reason and stop here ). ☐ Reason? _____

3. FACILITATE CONSENT

Immediate Teleconsent

Scan the QR code or visit bit.ly/btn-teleconsent to find the RA on call. Call the RA and check one of the boxes below:

If you experience technical difficulties, need to delay the Zoom meeting, or your patient changes her mind, call your RA immediately.



Zoom Room

Open the study iPad and scan the QR code or visit zoom.us/my/risestudy to join Zoom. Pass the iPad to the patient when the RA is reached. You are welcome to work during the meeting, but you OR the Advocate should remain in the room

24-Hour Consent

Work with patient to schedule a specific time to meet with the research team the next day. (e.g., 5:00pm PST on 8/11/2025).

ASAP is preferred. If necessary, you can schedule participant within 72 hours.

Collect patient's name, phone number, and email. Obtain ROI from patient to allow you to provide research team with patient's contact information. Fill out appointment card with appointment date and time, and give to patient.

Scan the RA On Call QR code (top left) or visit bit.ly/btn-teleconsent to call the RA who is on-call *right now* with the following information:

- **Participant name**
- **Participant phone number**
- **Participant email**
- **Appointment date and time**
- **Date of Assault**
- **Date of Exam**
- **SANE name**
- **Advocate name**
- **Your site**

The RA on-call will take care of everything else!

If there is no one on-call:

Text Jaidyn (984-895-7241) that you have a potential participant, and send her an email (jaidyn.macdonald@unlv.edu) including the information above. Please know that Jaidyn is *not* a backup, but will respond within 24 hours. Therefore, please do *not* schedule the appointment within 24 hours.
